



NOTIFICATION & CONSENT ON PERSONAL DATA PROCESSING

This Notification & Consent on Personal Data Processing (hereinafter – Notification Consent) is provided in compliance with the RA Law on Personal Data Protection (hereinafter referred to as Law). Personal data processor or Bank – “AMIO BANK” CJSC, address: Nalbandyan str. 48, Yerevan, RA.

By signing this Notification Consent, you confirm that you have read and understood this Notification Consent and agree to processing by the Bank of your personal data, i.e. name, surname, patronymic, gender, ID document details, Social Security Card or Social Services Number details or a statement of their absence, Citizenship, nationality, country of residence and tax residency, registration/address of residence, marital status and date, phone number, biometric data (face, fingerprint, etc.), education, place of employment, information regarding military service, information on criminal liability/convictions/other judicial and/or enforcement proceedings, and/or other information (including confirmation and date of birth, marriage, and death), which allows direct or indirect identification of the client's identity in accordance with the Law.

Your personal data will be processed for you to become a Bank client, sign a contract, have further access to services rendered by the Bank, receive notifications on promotions/offers/ run by the Bank and other services rendered.

A consent to your personal data processing is given to perform, in compliance with the Law operations on your personal data (collect, register, enter, coordinate, store, use, etc.) necessary for achieving the targets specified in this Notification Consent and fulfilling the obligations imposed on the Bank by the legislation.

By signing this Notification Consent, you authorize and empower the Bank to make inquiries to your place of employment, state and local self-government bodies, and/or information systems owned by other persons (including the "Nork" Social Services Technological and Awareness Center" Foundation, the "Electronic Governance Infrastructure Implementation Office" CJSC (EKENG)), and ACRA Credit Reporting LLC), as well as to provide them with your personal data and receive information about you. You also authorize the transfer of your personal and biometric data to organizations affiliated with the "Sumsb" group of companies for the purposes of online identification and transaction execution. These organizations are obligated to implement appropriate technical and organizational measures to ensure the security of personal and biometric data in order to achieve the purposes set forth in this Notification Consent. This Notification Consent is deemed given also if the above-mentioned authorities, serving as a source of those data are renamed, reorganized or replaced by other authorities/sources given that the volume of information to be received or provided based on this Notification Consent remains the same.



By signing this Notification Consent, you authorize and empower the Bank to provide your banking confidential information to the state and/or local self-government bodies of the Republic of Armenia, and/or foreign state authorized bodies, and/or persons designated by them, in accordance with the legislation of the Republic of Armenia, including Chapter 80.2 of the RA Tax Code, the United States Foreign Account Tax Compliance Act (FATCA), as well as the Common Reporting Standard published by the Organisation for Economic Co-operation and Development (OECD), and in cases and procedures established by international and/or interstate other acts.

You can find more detailed information about the personal and biometric data processed by the Bank, as well as the entities to which the Bank sends inquiries and/or provides data, at the Bank's branches or on the Bank's official website under the "Customer Rights" section. Your personal and/or biometric data is provided to these entities based on the relevant agreement and/or contract and/or other applicable document concluded with you, within the scope of and for the purposes stipulated therein.

The consent to the processing of personal and biometric data is considered granted by you, and the Bank obtains the right to process your personal and biometric data at the time of applying to the Bank to register as a customer of the Bank, when you have provided the Bank with your identity document, as well as during the validity period of the agreements concluded between you and the Bank for the purpose of performing the actions specified in those agreements, as well as for the purpose of providing it to organizations cooperating with the Bank/providing services to the Bank/performing work for the Bank in accordance with the RA Law "On Banking Secrecy", provided that this is necessary for the provision of such services or performance of such work and/or in all cases where the requirement for data processing is directly established by law.

This Notification Consent shall also be deemed granted in the event that the aforementioned entities, which are the sources of the aforementioned data, are renamed, reorganized, or replaced by other entities/sources, provided that the scope of the information to be obtained or provided based on this Notification Consent remains the same.

In case of your written withdrawal of consent to the processing of your personal and biometric data, or a request to correct or destroy personal and/or biometric data (if personal and/or biometric data are incomplete or inaccurate or outdated or were obtained illegally or are not necessary to achieve the purposes of processing). The Bank undertakes to stop processing your personal and/or biometric data or correct or destroy your personal and/or biometric data within ten business days, if there are no outstanding obligations between you and the Bank and there are no existing contractual relations, otherwise the contractual relations between you and the Bank are subject to termination with all negative consequences arising therefrom. In case of withdrawal of consent to the processing of your personal and biometric data or a request to destroy your personal and/or biometric data, your personal and/or biometric data ceases to be processed by the Bank, but they are stored in the information archive and can be used only in cases provided for by law. The withdrawal of consent does not have retroactive effect.

Consent to the processing of personal and biometric data is granted at the moment of applying to the Bank for customer registration and remains valid for the entire duration of the



agreements concluded between you and the Bank. In cases defined by legislation, the consent remains valid for the period specified for those cases. This consent shall also be considered valid in the event that the aforementioned entities, which serve as sources of such data, are renamed, reorganized, or replaced by other entities/sources, provided that the scope of the information to be obtained or provided under this consent remains unchanged.
